 - ii. Omnigraphics- ebooks are still being loaded into BiblioBoard

 - i. 595 ebooks-- access is coming soon
- d. Gale
 - i. 15 ebooks are available in Gale Ebooks

4. Resource Selection Cycle update:

- a. Licensing in progress- NC LIVE is working with UNC System Legal to finalize contracts

5. HomeGrown Ebooks Update

- a. Overdrive collaboration
 - i. 3,188 HomeGrown ebooks were loaded into Overdrive for libraries with Overdrive accounts on July 6th
 - ii. The rest of the ebooks will be loaded in 2024
- b. New ebooks
 - i. 340 new ebooks from 2022 donations have been purchased and loaded into BiblioBoard.
